## The Commonwealth of Massachusetts

AN ACT AUTHORIZING AND DIRECTING THE BOARD OF HIGHER EDUCATION TO CONSOLIDATE ALL COURSES IN ALL INSTITUTIONS OF HIGHER LEARNING OPERATED BY THE COMMONWEALTH WHICH FURNISH COURSES IN ART.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 The state board of education is hereby authorized and  
2 directed to consolidate all courses in all institutions of higher  
3 education operated by the commonwealth which provide for  
4 instruction in art. A new division for the instruction in art  
5 shall be established in the branch of the University of Massa-  
6 chusetts located in Boston.

The State of Massachusetts is hereby authorized and empowered to acquire by purchase or otherwise, in whole or in part, any real estate owned or controlled by any person or corporation, and to hold the same for the purpose of establishing a site for the State House, and to do all things necessary to carry out the purposes of this act.

### The Commonwealth of Massachusetts

AN ACT TO AUTHORIZE THE COMMONWEALTH TO ACQUIRE BY PURCHASE OR OTHERWISE, IN WHOLE OR IN PART, ANY REAL ESTATE OWNED OR CONTROLLED BY ANY PERSON OR CORPORATION, AND TO HOLD THE SAME FOR THE PURPOSE OF ESTABLISHING A SITE FOR THE STATE HOUSE, AND TO DO ALL THINGS NECESSARY TO CARRY OUT THE PURPOSES OF THIS ACT.

Enacted by the Senate and House of Representatives in General Court assembled, and by the majority of the members present in each house thereof, on the \_\_\_\_\_ day of \_\_\_\_\_, 192\_\_.
