The Commonwealth of Massachusetts

AN ACT INCREASING THE MEMBERSHIP OF THE MASSACHUSETTS AERONAUTICS COMMISSION BY TWO AND PROVIDING THAT ONE OF SUCH MEMBERS SHALL BE A GENERAL FIXED BASE OPERATOR.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The first paragraph of section 57 of the General
2 Laws, as amended by section 3 of Chapter 844 of the Acts of
3 1967, is hereby further amended by striking out the first two
4 sentences and inserting in place thereof the following: —

5 There shall be a commission to be known as the Massa-
6 chusetts Aeronautics Commission, consisting of seven mem-
7 bers to be appointed by the Governor, no more than four of
8 whom shall, at any one time, be members of the same political
9 party. Of the members so appointed three shall be persons
10 having practical experience in aeronautics and another one
11 shall be a general fixed base operator.

1 SECTION 2. The terms of the two additional members pro-
2 vided for in section 1 of this act shall expire on the first
3 Wednesday of January nineteen hundred and seventy-one and
4 their successors shall be appointed for a term co-terminous
5 with that of the Governor.
