AN ACT TO PROVIDE GREATER COMPETITION IN THE AWARD OF CONTRACTS FOR PUBLIC BUILDING PROJECTS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 149 of the General Laws, as amended, is hereby
2 further amended by adding at the end of section 44D the
3 following paragraph: —

4 If less than three sub-bids on any sub-trade are received and
5 such bids are not rejected by the awarding authority, and any
6 general bidder is precluded from using every sub-bid filed, the
7 awarding authority shall state, in an addendum issued with the
8 list of sub-bidders required by section forty-four H, an amount
9 which may be included by general bidders under Item 2 of the
10 general bid form for such sub-trade. Every general bidder may
11 either use such amount or name a sub-bidder he is not pre-
12 cluded from using. This amount shall be five percent greater
13 than the low filed sub-bid. If the selected general bidder uses
14 such amount, the procedure provided in section forty-four I (1)
15 shall be followed.
