**The Commonwealth of Massachusetts**

In the Year One Thousand Nine Hundred and Eighty-Five.

AN ACT FURTHER REGULATING THE ISSUANCE OF LICENSES FOR THE OPERATION OF CINEMATOGRAPHS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 143, Section 75, General Law, as most recently  
2 amended by Chapter 572, Section 275, Acts of 1980, is hereby  
3 further amended by striking out the fourth sentence and inserting  
4 in place thereof the following: — Licenses shall be valid through-  
5 out the Commonwealth but shall not be assignable or transferable.  
6 A license shall continue in force until the date of birth of the  
7 licensee occurring more than twelve months but not more than  
8 twenty-four months after the date of such license unless suspended  
9 or revoked for incompetence or untrustworthiness of the licensee.  
10 If any such license or the renewal thereof expires in an even year,  
11 any subsequent renewal shall expire on the next anniversary of the  
12 licensee's date of birth occurring in an even year. If any such license  
13 or renewal thereof expires in an odd year any subsequent renewal  
14 shall expire on the next anniversary of the licensee's date of birth  
15 occurring in an odd year. A license issued to a person born on  
16 February twenty-ninth shall for the purpose of this section expire  
17 on March first. Licenses not renewed at the expiration date shall  
18 become void, and shall after one year be reinstated only by re-  
19 examination of the licensee. A notice of the date of the expiration  
20 of a license shall, at least thirty days prior to such date, be sent to  
21 the licensee.
