

By Mr. White, a petition (accompanied by bill, Senate, No. 1489) of W. Paul White for legislation to authorize the consolidation of Greater Boston Council, Inc., Boy Scouts of America, and Minutemen Council, Inc., Boy Scouts of America. Commerce and Labor.

AN ACT AUTHORIZING THE CONSOLIDATION OF GREATER BOSTON COUNCIL, INC., BOY SCOUTS OF AMERICA AND MINUTEMEN COUNCIL INC., BOY SCOUTS OF AMERICA.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Greater Boston Council, Inc., Boy Scouts of
2 American and Minuteman Council, Inc., of the Boy Scouts of
3 America, both corporations established under the laws of the
4 Commonwealth, are hereby authorized to consolidate into one
5 corporation under the name of New BSA Council, Inc., which
6 shall be in all respects a continuation of each of said existing
7 corporations.

1 SECTION 2. Upon such consolidation, all property, real and
2 personal, of said existing corporations, and all devises, bequests,
3 conveyances and gifts, heretofore and hereafter made to either of
4 said existing corporations shall vest in said consolidated
5 corporation, and otherwise shall be held by said consolidated
6 corporation subject to the same terms, conditions, limitations and
7 trusts as they are now held by said existing corporations or would
8 have been held by said existing corporations but for this act, and
9 the treasurers of said existing corporations are hereby respectively
10 authorized to execute and deliver all papers and documents which
11 may be deemed necessary or proper for the purpose of confirming

12 in the consolidated corporation the record title to the property
13 of the existing corporations.

1 SECTION 3. Upon such consolidation, the members of the
2 existing corporations shall be the members of the consolidated
3 corporation until such time as the consolidated corporation may
4 by amendment of its by-laws alter its membership, and the
5 Directors of the existing Greater Boston Council, Inc., Boy Scouts
6 of America and Minuteman Council, Inc., shall be until their
7 successors are chosen and qualified the directors of the
8 consolidated corporation which shall, except as herein provided
9 with respect to initial membership, be governed by the by-laws
10 of said Greater Boston Council, Inc., Boy Scouts of America as
11 the same now are or may hereafter be amended.

1 SECTION 4. Upon such consolidation, the members of the
2 Board of Directors of the consolidated corporation shall be
3 authorized to amend Article I of the Articles of Organization of
4 the consolidated corporation to change the name of the
5 corporation to such name as the members of the board in their
6 sole discretion shall choose.
