By Mr. Bolling of Boston, petition of Royal L. Bolling, Jr., that the net proceeds from the excise imposed upon deeds, instruments, and writings in Suffolk County be distributed to the city of Boston. Taxation.

AN ACT PROVIDING FOR THE DISTRIBUTION OF THE DEEDS EXCISE TO THE CITY OF BOSTON.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding the provisions of chapter sixty-
2 four D of the General Laws, section eight A of chapter one hundred
3 and ninety of the acts of nineteen hundred and eighty-two, and
4 section twenty-three of chapter five hundred and forty-six of the
5 acts of nineteen hundred and sixty-nine, when the obligation of the
6 state treasurer to pay the excise imposed by chapter sixty-four D to
7 the city of Boston expires, in accordance with section eight A of
8 chapter one hundred and ninety of the acts of nineteen hundred and
9 eighty-two, the net proceeds from the excise imposed upon deeds,
10 instruments, and writings in Suffolk County shall thereafter, on or
11 before the last day of each calendar quarter, be distributed by the
12 state treasurer upon the certification of the commissioner of
13 revenue without further appropriation to the city of Boston to fund
14 the costs of Suffolk County borne by said city of Boston.

1 SECTION 2. Amounts received by the city of Boston under this
2 act shall not be considered in the determination of the amount of
3 any distribution of state assistance to said city.
