### AN ACT PROVIDING FOR STATE REIMBURSEMENT OF CERTAIN COSTS FOR A SCHOOL BREAKFAST PROGRAM.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

- 1 Chapter 71 of the General Laws is hereby amended by inserting
- 2 after section 72 the following section: —
- 3 *Section 72A.* The school committee shall provide a breakfast
- 4 program for students in schools and school districts where forty
- 5 per cent or more of the school lunches were served free or at a
- 6 reduced cost pursuant to section seventy-two. The commonwealth
- 7 shall reimburse the school committee providing said program once
- 8 only in the amount of ten cents for every breakfast served, but not
- 9 exceeding three thousand dollars per school, said reimbursement
- 10 shall cover any additional costs incurred by the school committee
- 11 not reimbursed by the federal government pursuant to 42 USC 1773.
