The Board reviewed the following Applications for Elevator Mechanic's License:

Deirdre Hosler, DPS Deputy General Counsel, presented the Board with a complaint filed by Casey Proper against Licensed Elevator Mechanic (EM-006067), Patrick Moriarty. Mrs. Hosler asked the Board to decide whether or not to hold a disciplinary hearing against Patrick Moriarty. The DPS legal division reviewed this complaint with the Chief of Elevator Inspections and they are in favor of holding a hearing. The complaint consists of allegations of unethical conduct exhibited by Patrick Moriarty while working on an elevator at the Oxford Apartments. Also, the complaint consists of allegations that Patrick Moriarty did not exhibit professionalism while working as a Licensed Elevator Mechanic. Deirdre Hosler made a recommendation that this complaint be reviewed by the Board of Elevator Regulations in terms of disciplinary action against the Registered Elevator Contractor, Elevator Services Inc. A motion was put forth by Lenny Chase to hold a disciplinary hearing against Patrick Moriarty, Licensed Elevator Mechanic EM-006067. The motion was seconded by Edward Sandell.
