## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Fifty-One.

### AN ACT RELATIVE TO THE DUTIES OF THE ASSISTANT COMMISSIONER OF STATE AIRPORT MANAGEMENT.

1    *Whereas*, The deferred operation of this act would  
2 in part tend to defeat its purpose, which is to protect  
3 the retirement privileges of persons selected to serve  
4 with a state board or commission, therefore, it is  
5 hereby declared to be an emergency law, necessary  
6 for the immediate preservation of the public con-  
7 venience.

*Be it enacted by the Senate and House of Representatives  
in General Court assembled, and by the authority of the  
same, as follows:*

1    SECTION 1. Chapter 6 of the General Laws is  
2 hereby amended by adding at the end of section 59B,  
3 inserted by section 2 of chapter 637 of the acts of  
4 1948, the following:—

5    The commissioner, with the approval of the board,  
6 shall appoint an assistant commissioner, who shall  
7 aid and assist him in the general supervision of all  
8 state owned airports, but the present incumbent of  
9 the position of legal counsel for the board shall be  
10 designated and appointed to said position of said  
11 assistant commissioner, and shall not be subject to  
12 the provisions of chapter thirty-one. He shall receive  
13 such salary, subject to appropriation, as the com-  
14 missioner, with the approval of the board, may fix.

15 Such assistant commissioner may be removed from  
16 office only upon the recommendation of the com-  
17 missioner, with the approval of four members of the  
18 board.

1 SECTION 2. Chapter 6 is hereby amended by  
2 adding at the end of section 59C, inserted by section 2  
3 of chapter 637 of the acts of 1948, and any amend-  
4 ments thereof, the following: — The incumbent of the  
5 position of assistant airport manager, Logan airport,  
6 on April first, nineteen hundred and forty-nine, shall  
7 hold office during good behavior, but subject, how-  
8 ever, to retirement under provisions of any applicable  
9 general or special law relative to retirement systems.

1 SECTION 3. This act shall take effect as of January  
2 first, nineteen hundred and fifty-one.
