## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Seventy-Five.

AN ACT MAKING SUPPLEMENTAL APPROPRIATIONS FOR THE MAINTENANCE OF CERTAIN COUNTIES, THEIR DEPARTMENTS, BOARDS, COMMISSIONS AND INSTITUTIONS, OF SUNDRY OTHER SERVICES, AND TO MEET CERTAIN REQUIREMENTS OF LAW AND GRANTING A SUPPLEMENTAL COUNTY TAX FOR SAID COUNTIES.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. To provide for supplementing certain items in  
2 the current appropriation act for each of the following counties,  
3 the following sums are hereby appropriated, subject to the  
4 provisions of law regulating the disbursement of county funds  
5 and the approval thereof, for the fiscal year from July first,  
6 nineteen hundred and seventy-five, to June thirtieth, nineteen  
7 hundred and seventy-six.
