Granting a County Tax for the County of Barnstable.

- Resolved, That the following sums are hereby appro-
- 2 priated for the expenses of the county of Barnstable for

- \$600 4 For interest on county debt, a sum not exceeding six 5 hundred dollars.
- 900 6 For reduction of county debt, a sum not exceeding 7 nine hundred dollars.
- 5,350 8 For salaries of county officers and assistants fixed by 9 law, a sum not exceeding five thousand three hundred 10 and fifty dollars.
- 1,000 11 For clerical assistance in county offices, a sum not ex-12 ceeding one thousand dollars.
- 4,100 13 For salaries and expenses of district and police courts, 14 a sum not exceeding four thousand one hundred dollars.
- 4,000 15 For salaries of jailors, masters and assistants, and sup-16 port of prisoners in jails and houses of correction, a sum 17 not exceeding four thousand dollars.
- 2,500 18 For criminal costs in the superior court, a sum not ex-19 ceeding two thousand five hundred dollars.
- 1,500 20 For civil expenses in the supreme and superior courts, 21 a sum not exceeding one thousand five hundred dollars.
