AN ACT PROVIDING WARRANTY REPAIR REIMBURSEMENT FOR MOTOR VEHICLE PARTS AT RETAIL.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The first sentence of section 6 of said chap-  
2 ter 93B, as appearing in the 1992 Official Edition, is hereby

2 ter 93B, as so appearing, is hereby amended by striking out in  
3 lines 12 and 13 the words "such labor" and inserting in place  
4 thereof the following words: — such labor and materials or parts.

2 chapter 93B, as so appearing, is hereby amended in line 15 by  
3 striking out the words "such labor and parts" and inserting in  
4 place thereof the following words: — such labor and material or  
5 parts.
