or bonds of the town and interest becoming due in the then current financial year, or votes for the temporary borrowing of money in anticipation of revenue or a vote declared by preamble by a two-thirds vote of the town meeting members present and voting thereon to be an emergency measure necessary for the immediate preservation of the peace, health, safety or convenience of the town, shall be operative until after the expiration of seven days exclusive of Sundays and holidays, from the dissolution of the meeting.

If, within said seven days, a petition signed by not less than five per cent of the registered voters of the town, containing their names and addresses as they appear on the list of registered voters, is filed with the selectmen asking that the question or questions involved in such a vote be submitted to the registered voters of the town at large, then the selectmen, after the expiration of five days, shall forthwith call a special meeting for the sole purpose of presenting to the registered voters at large the question or questions so involved. The polls shall be opened at two o'clock in the afternoon and shall be closed not earlier than eight o'clock in the evening, and all votes upon any questions so submitted shall be taken by ballot, and the check list shall be used in the same manner as in the election of town officers.

The questions so submitted shall be determined by a vote of the same proportion of the registered voters at large voting thereon as would have been required by law had the question or questions been finally determined at a representative town meeting, but no action of the representative town meeting shall be reversed unless at least twenty per cent of the registered voters shall so vote. Each question so submitted shall be in the form of the following question which shall be placed upon the official ballot:- "Shall the town vote to approve the action of the representative town meeting whereby it was voted (brief description of the substance of the vote)?" If such petition is not filed within said period of seven days, the vote of the representative town meeting shall become operative and effective upon the expiration of said period.

Chap. 157. AN ACT INCREASING THE LIMITATION ON CERTAIN RESIDENTIAL MORTGAGE LOANS.

Be it enacted, etc., as follows:

Paragraph 5 of subsection B of section 2 of chapter 167E of the General Laws, as appearing in section 9 of chapter 155 of the acts of 1982, is hereby amended by striking out the last

sentence and inserting in place thereof the following sentence:- No loan of this class shall be made or acquired for a sum in excess of one and one-quarter per cent of the deposits of such corporation or one hundred thousand dollars, whichever is the greater.

Chap. 158. AN ACT RELATIVE TO THE HOURS OF OPERATION OF MOTOR VEHICLES BY CERTAIN OPERATORS.

Be it enacted, etc., as follows:

The second sentence of the second paragraph of section 8 of chapter 90 of the General Laws, as appearing in section 1 of chapter 361 of the acts of 1973, is hereby amended by striking out, in line 3, the word "five" and inserting in place thereof the word:- four.

Chap. 159. AN ACT PROVIDING FOR A CHANGE IN THE BOUNDARY LINE OF A CERTAIN HISTORICAL DISTRICT IN THE TOWN OF FALMOUTH.

Be it enacted, etc., as follows:

Section 3 of chapter 654 of the acts of 1975 is hereby amended by inserting after the word "Road", in line 28, the words:- ; two strips 200 feet wide on the Northerly and Southerly sides of Main Street, extending approximately 1,650 feet to the Easterly side of Shore Street.
