**The Commonwealth of Massachusetts**

In the Year One Thousand Nine Hundred and Seventy-Seven.

AN ACT RELATIVE TO APPEALS FROM CLASSIFICATIONS AND WAGE DETERMINATIONS OF CERTAIN PUBLIC EMPLOYEES.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 149 of the General Laws is hereby amended by striking  
2 out section 27A, as appearing in chapter 461 of the acts of 1935,  
3 and inserting in place thereof the following section: —

4 *Section 27A.* Within three days prior to the award or bid  
5 opening of a public works contract, order or requisition, two or  
6 more employers of labor, or two or more members of a labor  
7 organization, or the awarding officer or official, or five or more  
8 residents of the town or towns where the public works are to be  
9 constructed may appeal to the commissioner from a wage  
10 determination, or a classification of employment as made by the  
11 commissioner, by serving on the commissioner a written notice to  
12 that effect. Thereupon the commissioner shall immediately cause  
13 a public hearing to be held on said wage determination or  
14 classification of employment. The commissioner shall render a  
15 decision not later than three days after closing of the hearing. The  
5 decision of the commissioner shall be final and notice thereof  
/ shall be given forthwith to the awarding official or public body.
