McCarthy of Norwood, a school teacher for said city. Public Service. [Local Approval Received.]

AN ACT REGARDING PENSION BENEFITS FOR CAROL J. MCCARTHY.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding the provisions of section four of
2 chapter thirty-two or any general or special law to the contrary,
3 the State-Boston Retirement Board is hereby authorized and
4 directed to grant to Carol J. McCarthy of Norwood, a school
5 teacher for the City of Boston, for the period of December
6 eleventh, nineteen hundred and seventy through August Thirty
7 first, nineteen hundred and seventy-six as creditable service for
8 the purposes of chapter thirty-two of the General Laws; provided,
9 however, that said Carol J. McCarthy shall pay into the State-
10 Boston Retirement System Annuity Savings Fund, in one sum or
11 in installments, as said board shall determine, an amount equal to
12 any retirement allowance or accumulated regular deductions
13 received by her under the provision of said chapter thirty-two.

14 Said Carol J. McCarthy shall also pay into said annuity savings
15 fund, in one sum or in installments, as said board shall determine,
16 an equal amount to the amounts which would have been deducted
17 from the regular compensation of Carol J. McCarthy for the
18 period from December eleventh, nineteen hundred and seventy
19 until August thirty first, nineteen hundred and seventy-six had she
20 been a member in service during that period. In addition to the
21 payment of the amount required by the preceding sentence, said
22 Carol J. McCarthy shall also pay into said annuity savings fund an

23 amount of interest such that upon the completion of such pay-
24 ments the value of her accumulated payments under this para-
25 graph, together with regular interest thereon, shall equal the value
26 of her accumulated regular deductions for such period which
27 would have resulted if such deductions had actually been made
28 from regular compensation during the aforementioned period.

29 Upon the completion of the payments required hereunder, the
30 State-Boston Retirement Board shall grant to said Carol J.
31 McCarthy creditable service for the period from December
32 eleventh, nineteen hundred and seventy, until August thirty-first,
33 nineteen hundred and seventy-six, provided that no such credit
34 shall be granted unless and until such payments are completed.

1 SECTION 2. This act shall take effect on its passage.
