AN ACT RELATIVE TO WEIGHT DISCRIMINATION.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of Chapter 151B of the General Laws,
2 as appearing in the 2000 Official Edition, is hereby amended by
3 inserting at the end thereof the following definitions:—

4 24. The term “weight” shall mean a numerical measurement of
5 the total body weight, the ratio of a person’s weight in relation to
6 height or an individual’s unique physical composition of weight
7 through the body size, shape, and proportions. For the purposes
8 off this chapter, weight shall encompass, but not be limited to, an
9 individual’s body size, shape proportions and composition which
10 make an impression of a person as fat or thin regardless of numer-
11 ical weight.
