DECISION

COHASSET SARRO, INC. DBA RED LION INN
71-85 SOUTH MAIN ST.
COHASSET, MA 02025

Cohasset Sarro, Inc. dba Red Lion Inn (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 3, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Kelleher's Report.

The following documents are in evidence:

1. Investigator Kelleher's Compliance Check Field Report dated April 10, 2013; and
2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FACTS

1. On Wednesday, April 10, 2013, at approximately 6:46 p.m., Investigators Carey and Kelleher conducted an investigation of the business operation of Cohasset Sarro, Inc. dba Red Lion Inn.
2. An underage operative working with investigators purchased an alcoholic beverage, a bottle of Budweiser Light beer, for five dollars and thirty cents (\$5.30). The underage operative was not asked for identification.



CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. As the licensee has been in business for fifteen (15) years and has had no previous violations, the Commission issues a **WARNING**.


