MEMORANDUM AND ORDER ON LICENSEE'S
REQUEST FOR RECONSIDERATION

UNION CLUB, INC.
141 CABOT STREET
BEVERLY, MA 01915
LICENSE#: 010000004
VIOLATION DATE: From 04/13/1985 to Present
HEARD: 08/23/2016

Union Club, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 21, 2016, regarding alleged violations of:

- 1) M.G.L. c. 138, §1- Failure to file with the Commission annually a list of the names and residences of its officers, together with the amount of salary or compensation received by each employee engaged in the handling or selling of alcoholic beverages;
- 2) M.G.L. c. 138 § 15A- Change of Officers and Directors in the non-profit corporation without authorization.

By decision dated June 22, 2016, the Commission found the Licensee in violation of the charges and indefinitely suspended the License effective forthwith until further written order from this Commission.

The Commission stated that it would consider issuing a further order upon written request of the Licensee showing good cause to reconsider this indefinite suspension and a hearing before the Commission that the Licensee attends.

By letter dated July 8, 2016, the Licensee requested a hearing to reconsider the indefinite suspension. The Licensee's counsel along with the Manager of Record and members of the Board of Directors attended a hearing before the Commission on August 23, 2016, and argued that good cause exists to reconsider the indefinite suspension.

There is one (1) audio recording of this hearing. The Commission took administrative notice of the Commission records regarding this Licensee.

CONCLUSION

Based on the evidence presented at the hearing, the Commission reconsiders and reverses its prior order of **INDEFINITE SUSPENSION** of the license of Union Club, Inc. **effective forthwith**.

The indefinite suspension is reconsidered and reversed to a suspension of time served from June 22, 2016 to August 23, 2016.
