DECISION

ASHBY MARKET, INC.
MAIN AND SOUTH ROAD
ASHBY, MA 01431

Ashby Market, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 25, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

1. Investigator Doyle's Compliance Check Field Report dated May 9, 2016; and
2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

1. On Monday, May 9, 2016, at approximately 5:55 p.m., Investigators Bailey and Doyle investigated the business operation of Ashby Market, Inc.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 25-oz. can Budweiser Light beer for two dollars and forty-nine cents (\$2.49). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business over 20 years and with only one previous violation, the Commission issues a **WARNING**.


