For members who have other insurance, the MassHealth Recipient Eligibility Verification System (REVS) reports the coverage type, carrier code, and policy number of the insurance listed on file. Appendix C of all MassHealth provider manuals lists in numeric order by carrier code the name and address of the other insurance so that you can bill that insurance before billing MassHealth.

If you receive written evidence (for example, an explanation of benefits or a letter from an employer) that a member does not have the insurance identified on REVS, has different insurance than what is reported on REVS, or no longer has insurance coverage, please mail or fax the information to:

#### I. Third-Party-Liability Coverage-Type Codes

The following is a list of TPL coverage-type codes that identify the type of insurance a member has. If you use the MassHealth Recipient Eligibility Verification System (REVS) Automated Voice Response (AVR) system, you will be given the following TPL coverage-type code. If you use a REVS POS device, WebREVS, or electronic transactions, you will receive a full description of the coverage type instead of a code.
