MEMORIAL.

*To the Honorable Senate and House of Representatives,
in General Court assembled :*

The undersigned, merchants and others, humbly represent to your honorable bodies, that during the past year, the State Bank in this city, has been of great service to the community, by a very high and liberal course which it has pursued under its banking privileges. And they further represent, that an extinction of its chartered privileges would be at this time very injurious. We therefore pray that you will, at an early period, take the subject into consideration, and in your wisdom revoke the act passed at the last session of the General Court, which act decreed that its charter shall cease on the first day of April next ensuing.
