AN ACT

Relating to Surveyors of Highways.

*Be it enacted by the Senate and House of Representatives, in General Court assembled, and by the authority of the same as follows:—*

1    SECT. 1. Surveyors of highways are hereby author-  
2 ized to take land adjoining highways for the purpose  
3 of necessary and proper drainage of said highways.

1    SECT. 2. When an owner of land thus taken  
2 suffers damage in his property in consequence thereof,  
3 he shall have the same remedy as is prescribed in  
4 sections nineteen and twenty of chapter forty-four of  
5 the General Statutes in reference to damage to prop-  
6 erty by reason of raising, lowering or other act done  
7 for the purpose of repairing highways.

1   SECT. 3. No surveyor of highways shall proceed  
2 to take land under section first of this act, without  
3 having first obtained, in writing, the assent of the  
4 selectmen of the town, or the mayor and aldermen of  
5 the city wherein such surveyor resides, and the said  
6 selectmen and mayor and aldermen may prescribe  
7 such limits to the amount of land so taken, and such  
8 conditions to the taking thereof, as they may deem  
9 expedient.

1   SECT. 4. This act shall take effect upon its  
2 passage.
