## **DECISION**

**MATTHEW NADEAU D/B/A PATRIOT PACKAGE  
394A PATRIOTS ROAD  
TEMPLETON, MA 01468  
LICENSE#: 1268-00019  
VIOLATION DATE: 06/01/2017  
HEARING DATE: 08/15/2017**

Matthew Nadeau d/b/a Patriot Package (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 15, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

1. Investigator Bailey's Compliance Check Field Report; and
2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

1. On Thursday, June 1, 2017, at approximately 6:47 p.m., Investigators Doyle and Bailey ("Investigators") investigated the business operation of Matthew Nadeau d/b/a Patriot Package.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Bud Light beer, for one dollar and seventy-five cents (\$1.75). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 10 years with no prior violations, the Commission issues a **WARNING**.
