Commonwealth of Massachusetts.

In the Year One Thousand Eight Hundred and Forty-Seven.

AN ACT

To establish Regulations concerning the Harbor of Boston.

BE it enacted by the Senate and House of Representatives, in General Court assembled, and by the authority of the same, as follows:

- 1 Sect. 1. No vessel which shall cast anchor in
- 2 the harbor of Boston, between India Wharf and Gray's
- 3 Wharf, shall anchor within five hundred feet of the
- 4 line described in the second section of an act entitled
- 5 "An Act to preserve the Harbor of Boston and to
- 6 prevent encroachments therein," passed on the nine-
- 7 teenth day of April, in the year one thousand eight

8 hundred and thirty-seven; and no vessel which shall 9 cast anchor between the easterly side of Lamson's 10 Wharf and the easterly side of Tuttle's Wharf, at East 11 Boston, shall anchor within five hundred feet of the 12 line described in the fifth section of an "Act con-13 cerning the Harbor of Boston," passed the seven-14 teenth day of March, in the year one thousand eight 15 hundred and forty, unless for the purpose of hauling 16 in, as soon as practicable, to some wharf in said har-17 bor, or unless compelled to do so by reason of stress 18 of weather or unavoidable casualty; and, for every 19 offence against either of the foregoing provisions, af-20 ter having been notified thereof by the harbor mas-21 ter, who may be appointed as hereinafter mentioned, 22 or by any party aggrieved, the master, commander, 23 or owners of such vessel, shall be subject to a pen-24 alty not exceeding twenty-five dollars.

Sect. 2. The master, commander or owners of 2 every vessel, shall, as soon as practicable, after having hauled to the end of any wharf that extends to 4 the channel in said harbor, cause her lower yards to 5 be cockbilled, and her jib-boom to be rigged in, so 6 that the said jib-boom may not annoy any other vestel or vessels going in or out of the adjoining docks; 8 and the lower yards and jib-boom shall be kept so 9 arranged while such vessel lies at the end of the 10 wharf as aforesaid, and until she is preparing immeliately to leave her berth; and for every offence 12 against any of the provisions in this section, the master, commander, or owners, or either of them, of such 14 vessel, shall be subject to a penalty not exceeding 15 ten dollars.

- 1 Sect. 3. No person shall throw or deposit in said
- 2 harbor, or any part thereof, any stones, gravel, bal-
- 3 last, cinders, ashes, dirt, mud, or other substances,
- 4 which may, in any respect, tend to injure the naviga-
- 5 tion thereof; and whoever shall offend against the
- 6 provisions of this section, shall be subject to a pen-
- 7 alty not exceeding fifty dollars.
- 1 Sect. 4. No warp or line shall be passed across
- 2 the mouth of any slip for the purpose of hauling a ves-
- 3 sel by said slip, before the vessel shall be within one
- 4 hundred feet of said slip, if the owners or occupants
- 5 thereof object, unless the harbor master, who may be
- 6 appointed as hereinafter mentioned, shall have decided
- 7 it to be necessary; and for every offence against this
- 8 provision, the master, commander, or owners of such
- 9 vessel shall be subject to a penalty not exceeding five
- 10 dollars.
- 1 Sect. 5. The city council of the city of Boston
- 2 may, if they shall deem it expedient, annually appoint,
- 3 by concurrent ballot in each board, a harbor master for
- 4 the port of Boston, who shall hold his office for one
- 5 year, and until another shall be appointed in his
- 6 place, or until he shall be removed by said city coun-
- 7 cil; and, before entering upon his office, he shall give
- 8 bond to the said city, with sufficient sureties, to the
- 9 satisfaction of the mayor and aldermen, in the penal
- 10 sum of two thousand dollars, conditioned for the faith-
- 11 ful discharge of the duties of said office: and in case
- 12 of the sickness or disability of the said harbor master,
- 13 he may appoint a deputy, subject to the approval of
- 14 said mayor and aldermen, to perform his duties during

- 15 such sickness or disability; and said harbor master
- 16 shall be allowed and paid quarterly, out of the city
- 17 treasury, such salary for his services as said city coun-
- 18 cil shall, from time to time, establish.
 - 1 SECT. 6. It shall be the duty of the said harbor
 - 2 master to enforce the execution of the several provi-
 - 3 sions of this act and of all other laws of the Common-
 - 4 wealth relating, in any way, to said harbor, and of all
 - 5 by-laws of said city not repugnant thereto; and to
 - 6 prosecute all violations of such laws and ordinances,
 - 7 and to take all lawful measures to prevent the doing
 - 8 of any act by which the flow of the tides, or the
 - 9 force, direction or depth of the current into, out of,
- 10 or through the said harbor may, in any degree, be in-
- 11 juriously affected. And said harbor master shall also
- 12 have authority so to regulate the anchorage of vessels
- 13 that, as far as may be practicable, the channel shall
- 14 be kept clear from the wharves to Castle Island.
 - 1 Sect. 7. All said several penalties may be recov-
 - 2 ered by complaint before the police court of the city
 - 3 of Boston, or by indictment, for the use of the said
 - 4 city.
 - 1 Sect. 8. This act shall take effect on and after

2 the first day of July next.
