AN ACT REGULATING THE SELECTION AND MANAGEMENT OF JURORS FOR
ESSEX COUNTY.

Be it enacted by the Senate and House of Representatives in General Court assembled and by the authority of the same, as follows:

1 SECTION 1. Section 1 of chapter 234A of the General Laws is
2 hereby amended by inserting after the word "county", in line 2, and
3 in lines 8 and 9, in each instance, the words: — and in Essex county.

1 SECTION 2. Section 2 of said chapter 234A is hereby amended
2 by inserting after the word "county", in line 2, the words: — and for
3 Essex county.

1 SECTION 3. Section 3 of said chapter 234A is hereby amended
2 by inserting after the word "county", in line 4, the words: — and in
3 Essex county, — and by inserting after the word "county", in line
4 21, the words: — and Essex county.

1 SECTION 4. Section 5 of said chapter 234A is hereby amended
2 by inserting after the word "county", in line 2, the words: — and
3 Essex county.

1 SECTION 5. Section 6 of said chapter 234A is hereby amended
2 by inserting after the word "county", in line 4, the words: — and
3 Essex county.

1 SECTION 6. Section 7 of said chapter 234A is hereby amended
2 by inserting after the word "county", in line 3, the words: — and
3 Essex county.

1 SECTION 7. Section 9 of said chapter 234A is hereby amended
2 by inserting after the word "county", in line 1, the words: — and
3 Essex county.

1 SECTION 8. Section 10 of said chapter 234A is hereby amended
2 by inserting after the word "county", in line 3, the words: — and
3 Essex county.

1 SECTION 9. Said section 10 of said chapter 234A is further
2 hereby amended by adding the following sentence: — The aggre-
3 gate of prospective juror lists from all cities and towns of Essex
4 county shall be known, and hereinafter referred to, as the "master
5 juror list" for Essex county.

1 SECTION 10. Section 11 of said chapter 234A is hereby amend-
2 ed by inserting after the word "county", in line 1, the words: — and
3 Essex county.

1 SECTION 11. Section 12 of said chapter 234A is hereby amend-
2 ed by inserting after the word "county", in line 3, the words: — and
3 Essex county.

1 SECTION 12. Section 35 of said chapter 234A is hereby amend-
2 ed by inserting after the word "county", in line 16, the words: —
3 and Essex county.

1 SECTION 13. The provisions of section one, two, three A, four
2 to twelve, inclusive, seventeen to twenty-four B, inclusive, twenty-
3 six B, thirty-two, thirty-six and forty-one of chapter two hundred
4 and thirty-four of the General Laws shall become inapplicable as to
5 Essex county upon the applicable provisions covering the same
6 subject matter in the various sections of chapter two hundred and
7 thirty-four A becoming effecting as otherwise provided in this act.

1 SECTION 14. Section 25 of chapter 262 of the General Laws is
2 hereby amended by striking out the two sentences added by section
3 9 of chapter 415 of the acts of 1977 and inserting in place thereof the
4 following two sentences: — This section shall not apply in Middle-

5 sex county and Essex county. The compensation of grand and trial
6 jurors who serve in Middlesex county and in Essex county shall be
7 governed by the applicable provisions of chapter two hundred and
8 thirty-four A.

1 SECTION 15. Section 2A of chapter 277 of the General Laws is
2 hereby amended by striking out the sentence added by section 10 of
3 chapter 415 of the acts of 1977 and inserting in place thereof the
4 following sentence: — In Middlesex county and in Essex county,
5 the clerk of the courts shall send a letter of venire to the jury
6 commissioner as set forth in section twelve of chapter two hundred
7 and thirty-four A.

1 SECTION 16. Section 2B of said chapter 277, as most recently
2 amended by section 12 of said chapter 415, is hereby further
3 amended by inserting after the word “county”, in line 1, the words: —
4 and in Essex county.

1 SECTION 17. Section 3 of said chapter 277 is hereby amended
2 by striking out the sentence added by section 12 of said chapter 415
3 and inserting in place thereof the following sentence: — In Mid-
4 dlesex county and in Essex county, the selection and management
5 of grand jurors shall be governed by chapter two hundred and
6 thirty-four A and other applicable provisions of the General Laws.

1 SECTION 18. Section 4 of said chapter 277 is hereby amended
2 by striking out the sentence added by section 13 of said chapter 415
3 and inserting in place thereof the following sentence: — In Mid-
4 dlesex county and in Essex county, letters of venire shall be issued
5 to the jury commissioner as set forth in chapter two hundred and
6 thirty-four A.
