
## About the Board of Early Education and Care:

Under the Board's oversight and regulations, the Department of Early Education and Care licenses child care programs, residential programs, and adoption/foster care placement agencies; provides financial assistance for over 56,000 children to attend high-quality programs that support their growth, development and learning; and provides information and referral services, inclusive programming for children with special needs, parenting and family support, and professional development opportunities for early educators. The Board of Early Education and Care is comprised of eleven members, two of whom are ex-officio and nine
