**DECISION**

**ADONIS, INC. D/B/A QUICK MART  
58 SOUTH MAIN STREET  
MILFORD, MA 01757

Adonis, Inc. d/b/a Quick Mart (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 10, 2019, regarding an alleged violation of 204 CMR 2.05 (2)-Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Keefe's Report.

The following documents are in evidence:

1. Investigator Keefe's Compliance Check Field Report;
  2. Licensee Stipulation of Fact; and
  3. Copy of Licensee's License Application Approved March 2001.
- A. Copy of Licensee's Server Training Certificate.

**FACTS**


1. On Wednesday, May 29, 2019, at approximately 7:35 p.m., Investigators Di Cicco and Keefe ("Investigators") investigated the business of Adonis, Inc. d/b/a Quick Mart.
2. An underage operative, working with Investigators, purchased from the Licensee alcoholic beverages, a 24-ounce container of Twisted Tea malt beverage. The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2001 with no prior violations.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21). The Commission issues a **WARNING**.
