AN ACT MAKING APPROPRIATIONS FOR THE FISCAL YEAR ENDING JUNE THIRTIETH, NINETEEN HUNDRED AND SIXTY-FIVE, TO PROVIDE FOR SUPPLEMENTING CERTAIN EXISTING APPROPRIATIONS AND FOR CERTAIN NEW ACTIVITIES AND PROJECTS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. To provide for supplementing certain appropria-
2 tions previously made and for certain new activities and projects,
3 the sums set forth in this act are hereby made available from
4 the funds designated, to be in addition to any amounts other-
5 wise available for the purpose, subject to the provisions of law
6 regulating the disbursement of public funds and the approval
7 thereof and the conditions pertaining to the appropriations in
8 chapter three hundred and thirty-seven of the acts of nineteen
9 hundred and sixty-four.
