ACTIVITIES

The Board held 23 meetings during the period from July 1, 1947 to June 30, 1948.

There were 67 applicants interviewed at these meetings.

There were 43 applications filed.

39 applicants were certified.

9 application fees were refunded.

1 renewal fee was refunded.

5 National Council Senior (Oral) Examinations were conducted for the National Council and reports compiled and forwarded to the Council.

9 National Council Junior (Oral and Written) Examinations were conducted for the National Council and reports compiled and forwarded to the Council.

801 Renewals were received during this period.

A written examination was conducted on May 14,15,16,17, 1948 for 22 candidates: 7 of whom desired National registration.

900 Architects were registered as of June 30, 1948.

The Board is a Member of the National Council of Architectural Registration Boards.
