SECTION 19. This act shall take effect upon its acceptance by the Massachusetts Bay Transportation Authority after the coverage under the Social Security Act of the police officers of said Authority has been terminated, but not otherwise.

**Chap. 1013.** AN ACT PROVIDING A CRIMINAL PENALTY FOR ALLOWING EXCESS FUEL TO BE DISCHARGED INTO THE ATMOSPHERE FROM AN AIRCRAFT.

*Be it enacted, etc., as follows:*

SECTION 1. Chapter 111 of the General Laws is hereby amended by inserting after section 142E the following section: —

*Section 142F.* Whoever, except in an emergency, allows excess fuel to be discharged into the atmosphere from an aircraft shall be punished by a fine of not less than two hundred and fifty dollars nor more than seven hundred and fifty dollars. As used in this section "excess fuel" shall mean that quantity of unused fuel which collects in "drain cans" from the engines of aircraft following the starting up or the shutting off of such engines, and "drain can" shall mean that receptacle located below or adjacent to an aircraft engine in which unused fuel collects or is collected when the engine is not in operation or just after the engine has been put into operation.

SECTION 2. This act shall take effect on January the first, nineteen hundred and seventy-three.

**Chap. 1014.** AN ACT AUTHORIZING THE COMMISSIONER OF COMMERCE AND DEVELOPMENT TO APPOINT A SPECIAL REPRESENTATIVE IN THE BUREAU OF ECONOMIC DEVELOPMENT FOR WESTERN MASSACHUSETTS.

*Be it enacted, etc., as follows:*

The second paragraph of section 9 of chapter 23A of the General Laws, as appearing in section 1 of chapter 636 of the acts of 1964, is hereby amended by inserting after the word "trade", in line 4, the words: — a special representative in the bureau of economic development for western Massachusetts, — and by striking out, in line 8, the word "nine" and inserting in place thereof the word: — ten.

**Chap. 1015.** AN ACT AUTHORIZING THE COMMISSIONERS OF PLYMOUTH COUNTY TO RECONSTRUCT AND MAKE EMERGENCY REPAIRS TO A BRIDGE OVER THE NORTH RIVER BETWEEN THE TOWNS OF MARSHFIELD AND NORWELL AND RELATIVE TO THE DESIGNATION OF SAID BRIDGE AS A FIXED BRIDGE.

*Be it enacted, etc., as follows:*

SECTION 1. The commissioners of Plymouth county are hereby authorized to reconstruct, without a draw, subject to the laws of the
