By Mr. Weekes of Harwich, petition of Stephen Weekes that provision be made for an assistant clerk in the Second District Court of Barnstable. Public Service.

AN ACT PROVIDING FOR AN ASSISTANT CLERK IN THE SECOND DISTRICT COURT OF BARNSTABLE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 The first paragraph of section 10 of chapter 218 of the Gen-
2 eral Laws is hereby amended by striking out the second sen-
3 tence, as most recently amended by chapter 578 of the acts of
4 1968, and inserting in place thereof the following sentence:—
5 Assistant clerks with salaries payable by the county may be
6 appointed in the central district court of northern Essex, the
7 municipal court of the Charlestown district, the municipal
8 court of the Brighton district, the district court of western
9 Hampden, the district court of Newton, the district court of
10 northern Norfolk, the district court of Chicopee, the municipal
11 court of Brookline, the first district court of southern Middlesex,
12 the first district court of Barnstable, the second district court of
13 Barnstable, the district court of western Norfolk, the fourth dis-
14 trict court of Bristol, the third district court of Plymouth, and
15 in courts the judicial districts of which have, according to na-
16 tional or state census last preceding, a population of sixty thou-
17 sand or more.
