AN ACT MAKING APPROPRIATIONS FOR THE FISCAL YEAR ENDING
JUNE THIRTIETH, NINETEEN HUNDRED AND SEVENTY.

*Be it enacted by the Senate and House of Representatives in
General Court assembled, and by the authority of the same, as
follows:*

1 SECTION 1. To provide an appropriation to pay compensation
2 to certain state employees for the period ending June twenty
3 eighth, nineteen hundred and sixty-nine and to provide supple-
4 menting items of appropriation in the fiscal year ending June
5 thirtieth, nineteen hundred and seventy, the sums specified in
6 section two are hereby appropriated subject to the provisions of
7 law regulating the disbursement of public funds and the condi-
8 tions pertaining to appropriations in chapter four hundred and
9 fifty-two of the acts of the current year and for such period as
10 may be specified, the sums appropriated to be in addition to any
11 amount at present available for such purposes.

1 SECTION 2.

9990-0050	For the cost of certain salary adjustments for the period beginning December twenty-nine, nineteen hundred and sixty-eight and ending June twenty eight, nineteen hundred and sixty-nine as authorized by chapter five hundred and forty-seven of the acts of the current year and for certain other salary adjustments during said period, that the governor upon recommendation of the com- missioner of administration, shall allocate to the state or other funds the amounts necessary to meet the cost of such salary adjustment properly chargeable to said funds and further pro- vided, that the unexpended balance in this item as of December thirty first, nineteen hundred and sixty-nine shall be transferred to and made available for the purpose of item 9990-0051 of sec- tion two of this act	\$30,700,000

- 9990-0051 For a reserve to meet the cost of certain salary adjustments authorized by chapter five hundred and forty-seven of the acts of the current year and for certain other salary adjustments, provided the governor, upon recommendation of the commissioner of administration, is hereby authorized to transfer from the sum appropriated to other items of appropriation for the fiscal year nineteen hundred and seventy, which are available in whole or in part for personal services, such amounts as are necessary to meet the costs of said adjustments, to be in addition to amounts otherwise appropriated for said services for said fiscal year; and further provided that the governor upon recommendation of the commissioner of administration, is further authorized to allocate the amount of such transfers to the several state or other funds to which such item of appropriation are charged . . . \$55,000,000

1 SECTION 3. This act shall take effect upon its passage.
