MEMORANDUM OF THE SECRETARY OF THE COMMON-WEALTH PURSUANT TO GENERAL LAWS, CHAPTER 3, SECTION 7, WITH RESPECT TO PETITION OF RUSSEL L. BARSH AND CHARLES F. FLAHERTY, JR., FOR LEGISLA-TION TO PROVIDE FOR THE ENCOURAGEMENT AND PRESERVATION OF AMERICAN INDIAN SCHOLARS AT HARVARD UNIVERSITY.

February 21, 1973.

To the Honorable Senate and House of Representatives:

The above-named petition was transmitted to me by the Clerk of the House of Representatives on January 22, 1973, with a request for a memorandum.

President and Fellows of Harvard College, the name of the corporation as it exists today was founded by an Act of the General Court of the Colony of Massachusetts Bay on October 28, 1636. On November 20, 1637, by an Act of the same body the board of overseers was created, and on March 13, 1638 by an Act of the same body the name of the college was established as Harvard College. On September 27, 1642 by an Act of the same body the board of overseers was reorganized and was made the sole governing body of the college with quasi corporate powers. On May 31, 1650 the first charter was granted to the corporation and the name of the corporaon was changed to President and Fellows of Harvard College. On October 8, 1692 by an Act of the same body a new charter was granted to the corporation. Under the provisions of Chapter 10 of the Acts of 1692-1693 of the General Court of the Colony of Massachusetts Bay, the President and Fellows of Harvard College were authorized to confer academic degrees. Under the provisions of Section 1 of Chapter 5 of the Constitution of the Commonwealth of Massachusetts all of the powers, authorities, rights, liberties, privileges, immunities and franchises which the President and Fellows of

Harvard College then had or were entitled to have, hold, use, exercise and enjoy were ratified and confirmed. There have been numerous Acts of the Legislature since the adoption of the Massachusetts Constitution affecting the corporation, the latest of which is Chapter 349 of the Acts of 1967 relating to the election of overseers of Harvard College.

The bill before your honorable bodies is an Act for the encouragement and preservation of American Indian Scholars at Harvar University, and discharge of said University's obligations to the Commonwealth in that behalf.

Please note that according to the records in this office the true name of the corporation is: President and Fellows of Harvard College not: Harvard University as the name appears in the petition.

Special legislation is required to effect the desired result.

Whether or not this should be allowed is a matter of policy within your exclusive jurisdiction, and this office expresses no opinion on the merits of the bill. No fee is required to be paid by a corporation of this type under the provisions of Chapter 3, Section 7.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The General Court has determined that, in the

13 employ the proceeds of its liquidation to build a new college;

14 that the Commissioners of the United Colonies of New England

15 conditioned said leave upon the provision thereafter by the Presi-

16 dent and Fellows of Harvard College to any Indian scholars at

17 Harvard of their studies rent-free; that the Indian College was

18 employed for the housing of non-Indian scholars and that no 19 Indian at Harvard then or thereafter has enjoyed his studies rent-

20 free while at Harvard; that pursuant to Pt.2 c.5 \$1 Art.2 of the

21 Declaration of Rights all grants made to the President and

- 22 Fellows of Harvard College shall be administered according to the
- 23 true intent of the grantors; and that pursuant to Pt.2 c.5 \$1 24 Art.3 of the Declaration of Rights this General Court is

- 26 best interests and advancement of the University and of letters, in
- 27 such manner as the Assembly of the Colony of the Massachusetts
- 28 Bay might have done, and that grantors here, the Commissioners
- 29 of the United Colonies of New England, were a representative
- 30 body composed of delegates of each of the Assemblies of New
- 31 England including that of Massachusetts Bay.
 - 1 SECTION 2. The President and Fellows of Harvard 2 University shall appoint a Chancellor of Indian Studies, and in
 - 3 addition thereto shall establish, endow and maintain at their own
 - 4 charge, not fewer than twenty-five Indian Fellowships distributed
 - s among the various Colleges and graduate schools of said
 - 6 University and administered by said Chancellor of Indian Studies,
 - 7 which Fellowships shall be available only to American Indians
 - 8 admitted to Harvard University. Said Fellowships shall in amount
 - 9 be equal to the current charge for tuition, room and board in the 10 facilities of said University as computed and adjusted each
- 11 semester, and shall be identified and described in all printed
- 11 semester, and shall be identified and described in all printed 12 announcements regarding financial aid distributed by said
- 13 University. Provided, that nothing herein shall be construed to
- 14 require that any Indian Fellow during his tenure reside at any of
- 15 the residential facilities owned and operated by said University.
