AN ACT RELATIVE TO THE NUMBER OF LICENSES TO BE GRANTED IN ANY CITY OR TOWN FOR THE SALE OF ALCOHOLIC BEVERAGES.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 17 of chapter 138 of the General Laws
2 as amended is hereby further amended by inserting before the
3 last paragraph thereof the following new paragraph:—

4 In determining the population of any city or town for the
5 purposes of this section, no account shall be taken by the
6 local licensing authority of persons residing on military
7 reservations, located within such city or town.

1 SECTION 2. This act shall not affect present licensees.
