### AN ACT RELATIVE TO THE TERMS OF SURCHARGES UNDER THE SAFE DRIVER INSURANCE PLAN.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 113B of chapter 175 of the General Laws, as appearing in  
2 the 2000 Official Edition, is hereby amended, in line 191, by striking  
3 the word "five" and inserting in the place thereof the word "three";  
4 and is further amended, in lines 197-198, by striking the words "two  
5 thousand dollars" and inserting in the place thereof the words "three  
6 thousand dollars"; and by striking the third sentence of the thirteen  
7 paragraph and inserting in its place the following sentence:— "For  
8 the purposes of determining upward premium adjustments, the plans  
9 made effective on or after January first, two thousand and four, shall  
10 consider only those surchargeable incidents and comprehensive  
11 claims totaling seven hundred and fifty dollars with surcharge dates  
12 in the three year period immediately preceding the effective date of  
13 the policy."
