**AN ACT RELATIVE TO THE ENTRY OF MAY P. ROCHE INTO THE
TEACHERS' RETIREMENT SYSTEM.**

*Be it enacted by the Senate and House of Representatives in
General Court assembled, and by the authority of the same, as
follows:*

1 Notwithstanding any provision of general or special law to
2 the contrary, the teachers' retirement system is hereby author-
3 ized and directed to make May P. Roche of Fitchburg who
4 has been employed as a teacher in the public schools of Fitch-
5 burg from nineteen hundred and sixteen to nineteen hundred
6 and sixty-two and has been employed with tenure since No-
7 vember, nineteen hundred and forty-nine, a member in service
8 of said system, and said May P. Roche shall be allowed to
9 count as creditable service for purposes of retirement all or
10 any portion of the time spent by her as a teacher in the public
11 schools of the commonwealth, provided, she, before the date
12 any retirement allowance becomes effective for her, pays into
13 the annuity savings fund of said system in one sum, or in
14 instalments, upon such terms and conditions as the teachers'
15 retirement board may prescribe, an amount equal to that
16 which would have been withheld as regular deductions from
17 her regular compensation had she been a member of said
18 system during all or any portion of her teaching career, plus
19 regular interest thereon to the date of final payment.

AN ACT TO AMEND THE LAW IN RELATION TO THE
