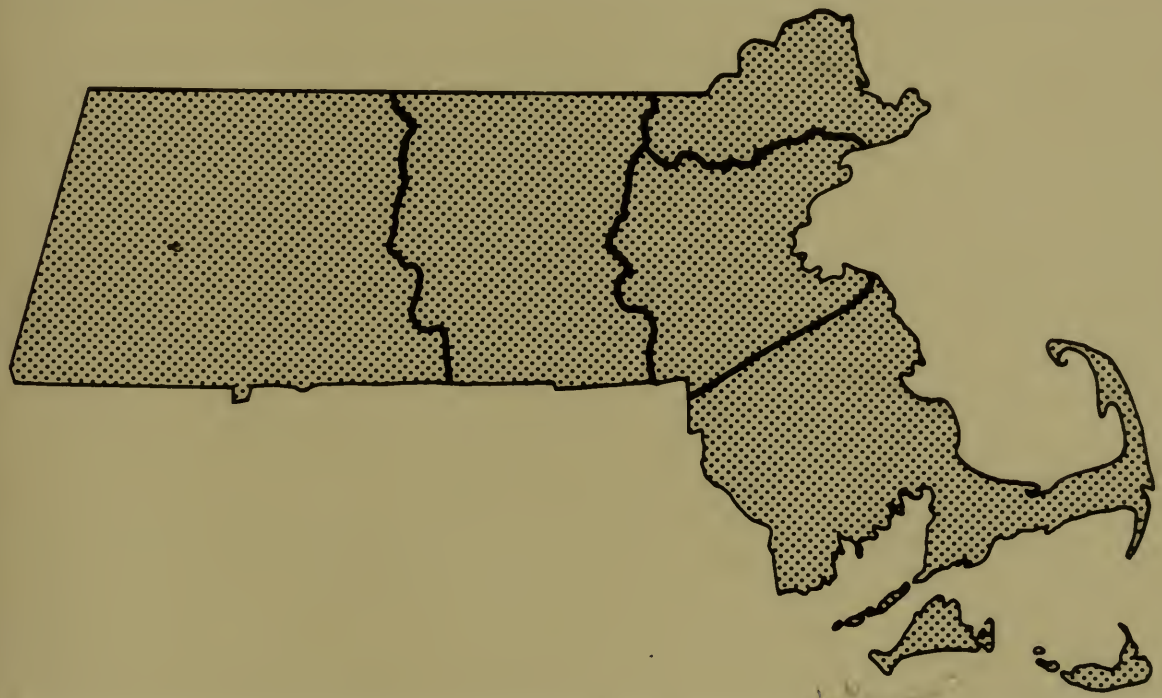
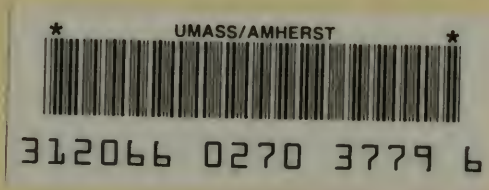

An Open Letter to Users of This Directory:





HOW TO USE THIS RESOURCE DIRECTORY

This resource directory is published in two formats. The first is a statewide directory, which lists treatment programs and resources for the information of attorneys, courts, human services agencies, hospitals and others likely to refer individuals to treatment programs throughout Massachusetts. The second is a series of five regional directories listing such services in the following Massachusetts regions:

- 1) Western Massachusetts (gold)
- 2) Central Massachusetts (orange)
- 3) Merrimack Valley (blue)
- 4) Metropolitan Boston (green)
- 5) Southeastern Massachusetts (yellow)

The statewide directory and the five regional directories list available programs such as private inpatient and outpatient, public inpatient and outpatient, and certain other selected resources within and outside Massachusetts. The regional directories should be most helpful to attorneys wishing to identify local resources for their clients. Attorneys in communities near the border of the regions may find it helpful to obtain two regional directories.

The directories differentiate privately and publicly funded programs. Privately-funded programs generally accept only clients who have third party reimbursement. The publicly-funded programs generally serve medically indigent clients, but also accept insured clients.

Frequently, attorneys may not be certain whether a client has a drinking problem or what type of treatment is appropriate for a client acknowledging a problem. In these instances, we recommend that clients be referred to an outpatient program for an assessment. The assessments generally indicate the level of impairment and the appropriate treatment resource.

The statewide and regional directories provide a comprehensive list of available resources but do not provide evaluations of the programs included. We suggest that anyone using the directories should become familiar with a program before making a referral to it.

A. RESIDENTIAL ALCOHOLISM SERVICES

Private rehabilitation programs provide treatment for withdrawal (detoxification). This is followed by rehabilitation services, consisting of education, group and individual counseling, family intervention and meetings of Alcoholics Anonymous, as well as other self-help groups. The programs vary in length from ten to twenty-eight days. These programs are focused primarily on the employed individual and usually anticipate a return to community living.

3. 14-DAY DUIL PROGRAMS

These mandated 14-day residential programs provide a preparation for treatment through assessment, education and motivational counseling to clients convicted of DUIL offenses. Virtually all clients are referred for follow-up care when they complete the 14 days. Although most clients attending the programs are second offenders, first offenders may be sent to these programs. Clients must be referred by a court.

6. DETOXIFICATION CENTERS

The detoxification programs provide medical assessment, treatment for withdrawal, counseling and referral services. The purpose of the detoxification facilities is to medically supervise the patient in the safe withdrawal from the acute phase of intoxication and to develop and implement a follow-up plan. Most clients stay for three to five days; many are referred to Halfway Houses or outpatient programs.
