AN ACT AUTHORIZING THE ISSUANCE OF AN ALCOHOLIC BEVERAGE
LICENSE TO IRISH-AMERICAN VETERANS ASSOCIATION.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Notwithstanding any other provisions of law, the licensing
- 2 board of the city of Malden is hereby authorized to issue to
- 3 Irish-American Veterans Association of Malden, a license to
- 4 sell all alcoholic beverages to be drunk on its premises to mem-
- 5 bers and bona fide guests only. Said license shall not be trans-
- 6 ferable.
