AN ACT INCREASING THE SALARY OF THE JUSTICE OF THE FIRST DISTRICT COURT OF BARNSTABLE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

8 "first district court of Barnstable,".
