AN ACT PROVIDING REWARDS FOR PERSONS AIDING IN THE CONVICTION OF PERSONS DISTRIBUTING CONTROLLED SUBSTANCES.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Chapter 94C of the General Laws as appearing in the 1986
- 2 Official Edition is hereby amended by adding the following
- 3 Section 49. —
- 4 Any person who initiates and voluntarily aides law enforcement
- 5 officials in the detection, arrest, and conviction of person(s) for
- 6 the unauthorized manufacture, distribution, or trafficking of
- 7 Class A, Class B, or Class C controlled substances, pursuant to
- 8 section 32, 32A, 32B, 32C of Chapter 94C, shall receive a reward
- 9 payable out of seized funds or property which are determined to
- 10 have derived from the aforesaid unauthorized drugs. Such reward
- 11 payment shall be calculated and payable in the amount of 2
- 12 percent of the seized proceeds.
