AN ACT FURTHER CLARIFYING THE AMOUNT OF INCOME OF CHILDREN IN COMPUTING THE RESOURCES OF A PARENT UNDER THE LAW RELATING TO OLD AGE ASSISTANCE AND MEDICAL ASSISTANCE FOR THE AGED, AND DISABLED PERSONS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Paragraph 8 of section 2A of chapter 118A of  
2 the General Laws, as appearing in chapter 614 of the acts of  
3 1957, is hereby amended by striking out the first sentence and  
4 inserting in place thereof the following sentence:—The word  
5 “income” as used in this schedule shall mean income after  
6 deducting state and federal income and social security taxes,  
7 union dues, insurance premiums, and in the case of govern-  
8 mental employees retirement contributions.

1 SECTION 2. Paragraph 7 of section 8 of chapter 118D of the  
2 General Laws, as amended by section 2 of chapter 659 of the  
3 acts of 1957, is hereby amended by striking out the first  
4 sentence and inserting in place thereof the following sen-  
5 tence:—The word “income” as used in this schedule shall  
6 mean income after deducting state and federal income and  
7 social security taxes, union dues, insurance premiums, and  
8 in the case of governmental employees retirement contribu-  
9 tions.
