NOTICE OF SUSPENSION

After a hearing on February 13, 2018, the Commission finds Gam Ro Inc. d/b/a Teele Square Liquors violated of M.G.L. c. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 count).

Therefore, the Commission suspends the license for six (6) days of which four (4) days will be served and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.

The suspension shall commence on Wednesday, April 25, 2018 and terminate on Saturday, April 28, 2018. The license will be delivered to the Local Licensing Board or its designee on Wednesday, April 25, 2018 at 9:00 A.M. It will be returned to the Licensee on April 29, 2018.

You are advised that pursuant to the provisions of M.G.L. c.138 § 23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.
