

Minutes of Executive Session
October 13, 2021 @ 12:22 PM

Commissioners Present: Chairman Philip Y. Brown, Commissioners Kathy Fallon, Kate Fitzpatrick, Michael Leung-Tat, James Machado, and Jennifer Sullivan. Commissioner MacKinnon was not present.

PERAC Staff Present: Executive Director John Parsons, Deputy Executive Director Caroline Carcia, General Counsel Judith Corrigan, Assistant Deputy Director Bill Keefe, Assistant Deputy Director Ken Hill, Associate General Counsel Katie Bense, Compliance Officer Thomas O'Donnell, Compliance Analyst John Galvin, Project Manager Tony Tse, and Senior Executive Assistant Kim Boisvert.

Mr. Parsons explained the protocol for the SFI filings which is located in Chapter 32, Section 20C. He stated that proper notice has been given to several individuals who have not filed their 2020 SFI. Some of these individuals believed that because they became inactive they would not have to file their SFI. However, according to the statute, those individuals still should have filed.

There was a brief discussion about an amendment to H. 17, if adopted, the inactive board members would not have to file an SFI if they served less than 30 days in a calendar year.

Mr. O'Donnell reported that he has reached out to the subject individuals and two (2) have stated that they have mailed their SFI and another has not responded to his phone calls. He continued that the Commission's next step is to formally remove those individuals as they can *never* become members of *any* Chapter 32 retirement board in the future.


