## **The Commonwealth of Massachusetts**

In the Year One Thousand Nine Hundred and Eighty.

---

*Ordered*, That a special committee, to consist of three members of the Senate to be designated by the President thereof, and six members of the House of Representatives to be designated by the Speaker thereof, is hereby authorized to make an investigation and study relative to the increasing cost of oil and gas.

Said committee shall be provided with quarters in the State House or elsewhere, may hold hearings, may travel within the Commonwealth, and may expend for clerical and other assistance and expenses such sums as may be appropriated therefor. Said committee shall report to the House of Representatives the results of its investigation and study, and its recommendations, if any, together with drafts of legislation necessary to carry its recommendations into effect, by filing the same with the Clerk of the House of Representatives on or before the last Wednesday in December, nineteen hundred and eighty.
