RESOLVE

For the payment of Military Bounty to Company D, Sixth Regiment, Third Brigade, Second Division of Massachusetts Volunteer Militia.

Resolved, That there be allowed and paid out of the treasury of the Commonwealth to John Abare and fifty-four others, late members of company D, sixth regiment, third brigade, second division of the Massachusetts volunteer militia, the sums set against their respective names in the accompanying pay-roll, for services performed as officers, non-commissioned officers, privates and musicians in said company, in the year eighteen hundred and fifty-seven, and not yet allowed them because of informality and incorrectness in the returns of said company to the adjutant-general.
