AN ACT FIXING AND ESTABLISHING MOTOR VEHICLE LIABILITY INSURANCE RATES FOR THE YEAR NINETEEN HUNDRED AND SEVENTY-ONE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

4 shall, on or before September fifteenth in the current year,
5 fix and establish the same classifications of risks and the same
6 basic premium charges or lesser charges to be used and

8 tion of motor vehicle liability policies or bonds, both as de-
9 fined in section thirty-four A of chapter ninety of the General
10 Laws, for the calendar year nineteen hundred and seventy-
11 one, as he fixed and established under the provisions of said
